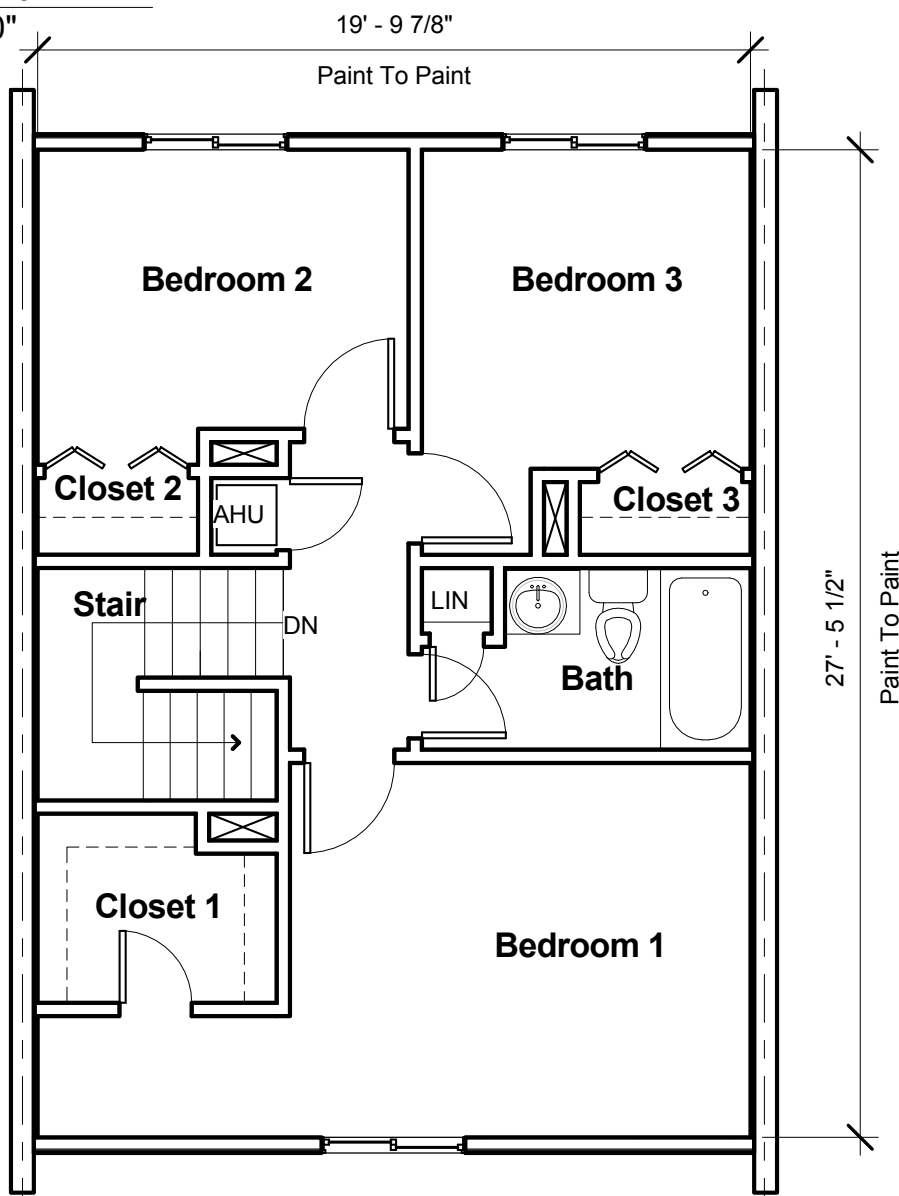


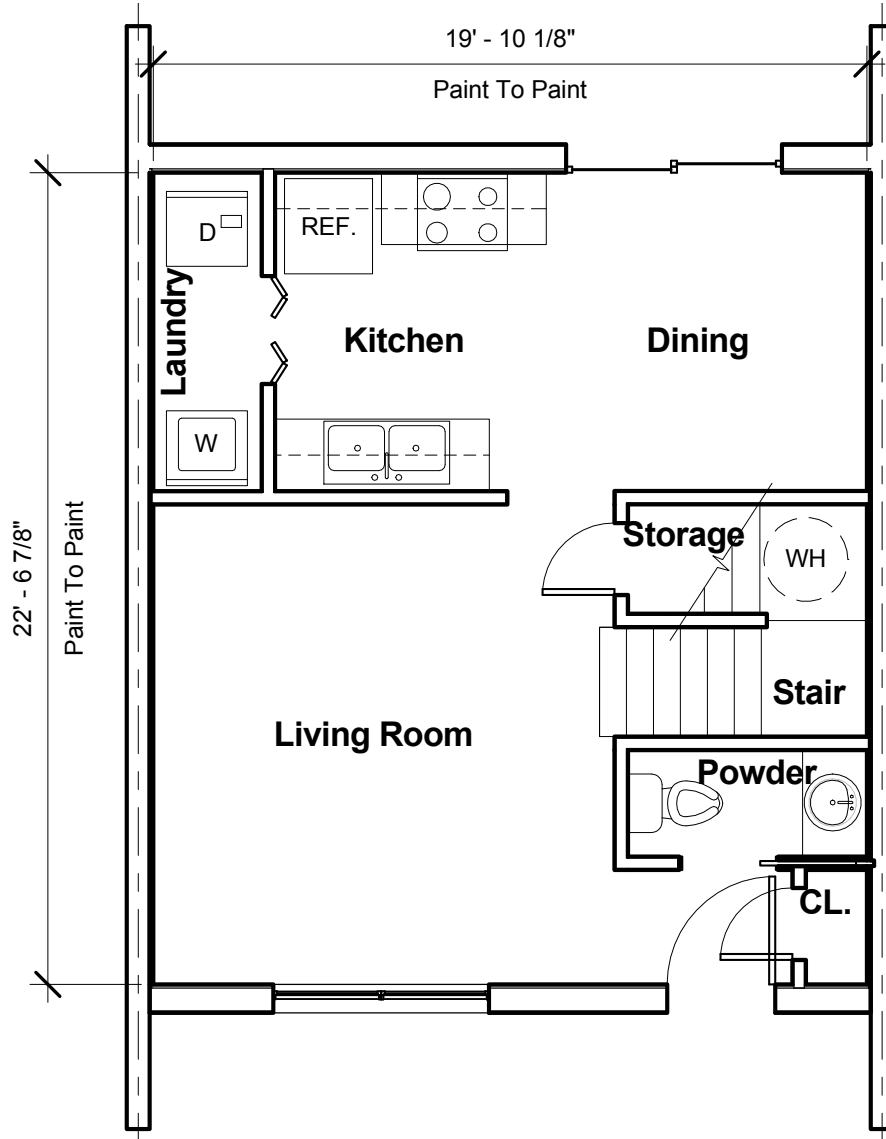
1 First Floor Plan

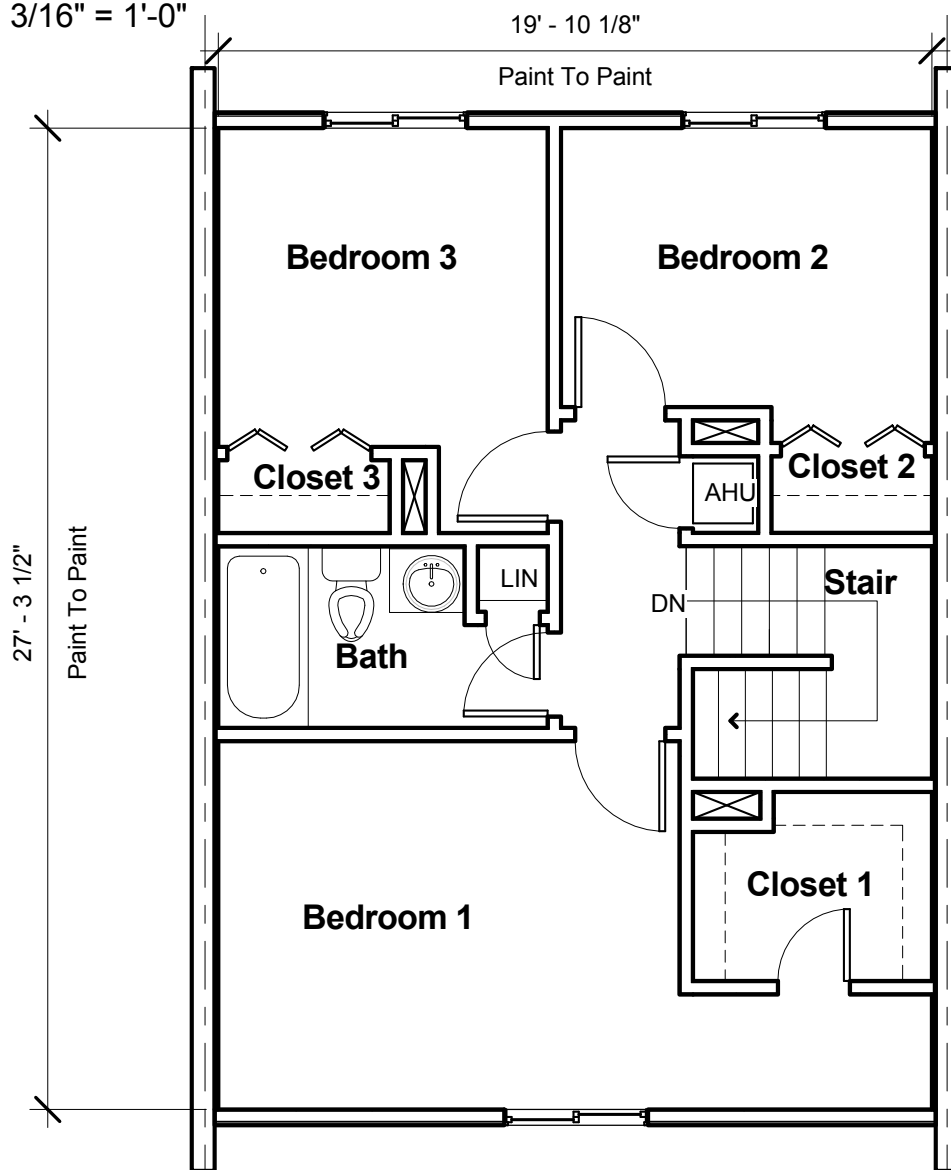
2 Second Floor Plan

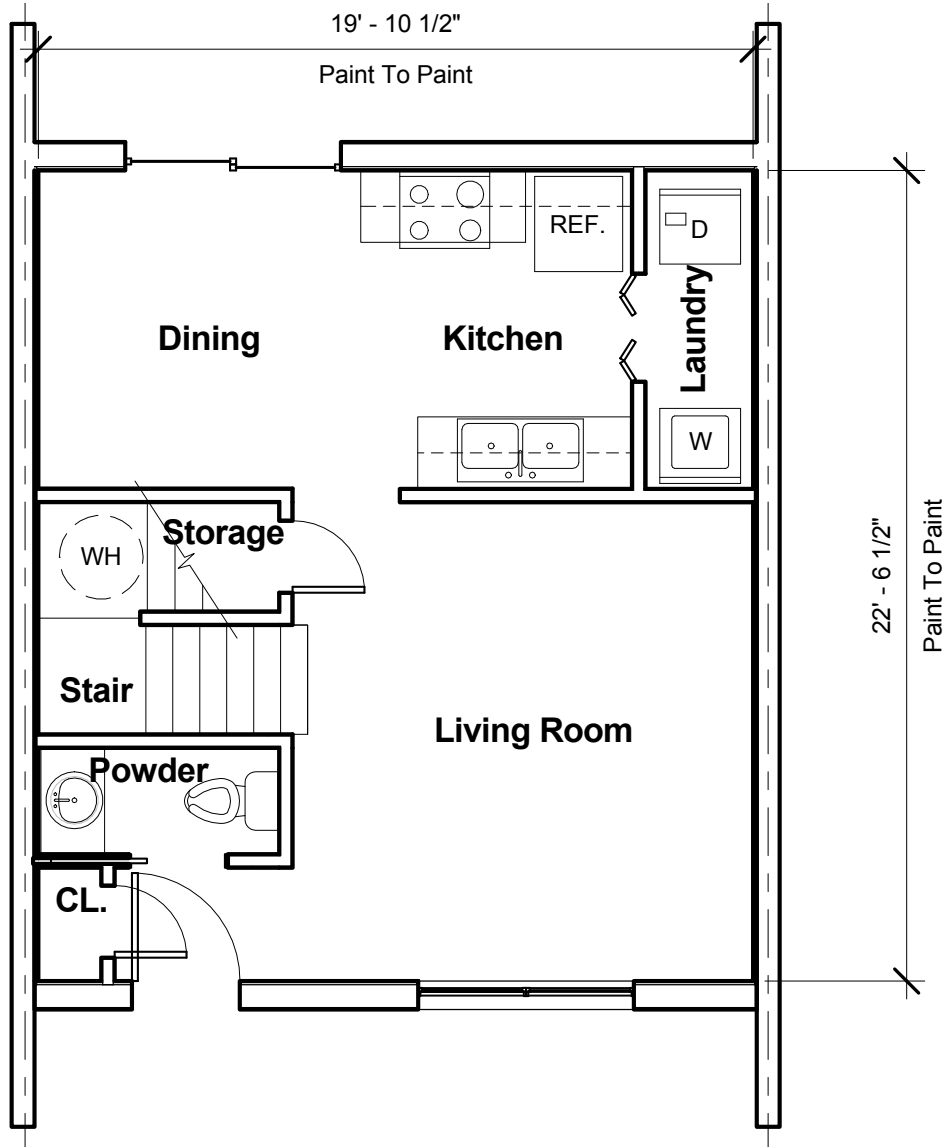
① First Floor Plan
